## Missouri Speleological Survey- President's Message - November 2021

The MSS had a Board meeting on September 18, 2021 at Bennett Spring State Park. The meeting was held in a beautiful stone pavilion overlooking the spring branch. Many thanks to Krista Bartel for organizing the meeting site and the group campground. Good times were had at camp with great company. The meeting was planned in conjunction with a mapping trip into Mary Lawson

Cave. The survey of this significant bat cave is being led by Matt Beeson. It's a sporting cave that's abundant in wildlife. Mapping in the presence of tens of thousands of gray bats is a remarkable experience, not fitting for the timid. We look forward to a return trip next year to continue documenting the extent of this sizeable cave.

The meeting itself was eventful as well. The Board approved a bylaws change in regards to our meeting schedule and frequency. We are now only required to have two meetings per year, rather than three, though more can be had if needed. Rather than deciding the next meeting date and location at the closure of a meeting, the President can now propose a meeting date, location and format to the Board via email with at least 30 days advance notice. Approval of upcoming proposed meetings can be determined by a majority of those Board members who respond to the call for a meeting within two weeks. This gives us much greater flexibility given the roving nature that our meetings have taken on, in order to accommodate mapping and other cave related projects which our meetings are typically planned around. Personally, I'm always wondering what could be done to better connect the larger caving community with the project cavers in the state or better yet, what can the MSS do to promote a long lasting caving community in Missouri. I always fall back on having caving opportunities available and exposing those who are already cavers along with potential new cavers to the fullfillment that comes with exploration, documentation and making contributions towards the goals of the MSS.

Much discussion was had around the wonderfully generous offer that Dave Hoffman made to donate his property to the MSS upon his death. Ultimately the consensus was that the MCKC may be better suited to receive such a significant land-holding. Were Dave to leave the property to the MCKC, it would, hopefully, still benefit the MSS as a site to possibly build on in the future, should there ever be such an interest, or as a camp site for when meetings are held in the Rolla area. We hope that Dave considers that option, but are confident that even if he chooses to go another direction that his decision will one grounded in conservation.

The meeting concluded with discussion of our next meeting. We are planning to hold an event the first weekend of March in Perryville. We discussed the possibility of holding the meeting either the first or second weekend of March. While there was a preference for the second weekend of March, another

scheduling conflict has led us to plan for holding the event the first weekend of March, instead. Cavers should plan to be able to camp at Berome Moore for the weekend. Caving trips will be held on Saturday, likely to caves owned by the City of Perryville. On Sunday morning we will have our meeting at a new conference center owned by the City of Perryville with the afternoon being a public outreach event for area residents and landowners. We will have access to the conference center the entire weekend. Planning for the event is still underway, but please go ahead and save the date and look ahead for further details. Hopefully we can coordinate with MCKC to also have their meeting that same weekend to make things easier for those who are involved with both organizations. For those who want to participate in the public outreach event, please let me know. We'll certainly need to have cavers around in the afternoon, after the meeting, to help. We look forward to seeing everyone.

Lastly, welcome to Stygian Grotto, who is the newest affiliate organization on the MSS Board. We look forward to Stygian expanding upon the collective knowledge of caves and karst in St. Charles, Warren, and Lincoln Counties as well as the surrounding areas by submitting data to the MSS Cave Files. As we welcome a new group to the MSS Board, I'd like to strongly encourage those Board members who represent our affiliate organizations to please try making it to MSS meetings, send a proxy or at least communicate if you're not planning to send anyone so that we know ahead of time whether we'll have a quorum.

Missouri Speleological Survey Files Report for November 1, 2021. We had a recent request for a list of deepest caves in the state. This came from the group of divers that just got past a tight restriction in Roaring River Spring (State Park) and so made a new record depth for the spring. Most recently, they reported a new depth of 451 ft. But did it qualify as a state record? Well, here's that list of caves greater than 200 ft "cave" depths (not necessarily single drop!). Please, if you have documentation to support any changes, let me know, see email address immediately below. There are 13 caves and springs on the list, with 7 accessible mostly/only to divers. For most springs, this is all water depth; Devils Well and The Gulf have significant air portion, but for the Gulf this extra 30 ft ceiling height isn't included. These 2 caves along with Blue Spring/Cannonball can have significant flood components of height that would vary from these numbers.

If you have **new information** on any Missouri caves, my email address is **slagrush@gmail.com**. We need your help to improve the database and make it more complete. I can and do work with Facebook entries, but for information or photos to be incorporated I need to be "private messaged" with the cave name and county.

Mark Brooks sent: -An email from Doug Leer describing passage that was recently surveyed and added to the map for Berome Moore Cave. Martin Carmichael sent: -A lead for a cave in Boone Co., but the 2005 vintage paperwork provided triggered more questions. Thankfully this paperwork provided a name that led to some answers. See Randy Long below. -A report on Carroll Cave where 8 Faunal Records were reported. Chouteau Grotto (anon) sent: -Entrance photos and GPS locations on Bell, Collapsed, Boundary Pit Caves and same information on 2 new caves, one to be called Fern Falls Cave and the other Ladder Cave. We have yet to decide if his 6 set of data fits Bruin Acres Cave or is a new cave. Jim Cooley sent: -6 photos from a recent gate repair at Onyx Cave in Pulaski Co. -14 historical Faunal Records for Big Mouth Cave in Oregon Co. Andy Free sent: -20 photos on 2 caves in Pulaski Co.: Fern Falls and Pine Bluff Caves. As above Fern Falls is a new addition for the county. Pine Bluff is "long lost" cave last reported on in 1956. Ken Grush sent: -A collection of map comparisons to LIDAR imagery for Dark, Refuge Cave No 1-2, Campsite and Indian No 2 Caves, all five in Crawford Co. Each was updated with GPS coordinates and with entrance photos. -144 transcribed Christian Co. reports from the now transcribed MoSpeleos v15 n3 & 4. I've used these transcripts to adjust credits in the Main Table of the database and show the complete report as published in MoSpeleo. Surprisingly, I found one published map that was not in our database previously. Scott House sent: -Updates for about 20 cave records in the operative database. He also added a new mine for Taney Co., Pinnacle Mine. -Sent modifications to the Main Table of the database for some 30 caves while he had the operative database for a weekend. Dan Lamping sent: -3 Faunal Records, cave description, directions and hydrology notes on Russell Cave in Ozark Co. -10 Faunal Records for his survey trip to Mary Lawson Cave in Laclede Co. during the MSS meeting weekend. Jon Lillestolen sent: -Communications of the diving activity at Roaring River Spring in the state park in Barry Co. A sketch to the "squeeze" and depth reports were sent. Joe Light sent: -More than 35 photos from a recent grotto trip to Greens Cave in Washington Co. He included a summary of the conditions he found and half a dozen Faunal Records. -A composite of 5 photos from an MVG trip to Fisher Cave in Franklin Co. from 1992. JJ Liebel sent: -Via Facebook and "private" Messenger an entrance photo for Shoat Hole Cave in Carter Co. Then promptly shared a folder of 100 of his photos from Mystery Cave in Perry Co. And shortly after another 180 photos from Wind and Gaping Caves in Shannon Co. -Over 180 photos of a trip Greens Cave in Washington Co. (see Light above). Alex Litsch sent: -A nice report of Roubidoux Cave and its wildlife. The cave and access are managed with the landowner through MCKC now. The hope is to further protect and conserve the cave through this new management agreement with MCKC. -An email with an update on Mud Cave in Gasconade Co., landowner apparently blocked the cave entrance with a large boulder! -A report on a new cave, Cedarledge Spring Cave in Jefferson Co. A dozen photos, videos, description and 6 Faunal Records were included. -A report of bad air in Fogging Pit. And 3 faunal records for Fogging Pit and Pentagon Pit. Randy Long sent: -Answers to the questions that Carmichael's "paperwork" suggested (see above). Long had the same paperwork in color which indicated all the data that originated from another cave but wasn't removed from the document. It was confusing to sort out what was new and what was old without the highlighting. The lead still needs a field check, but photos certainly suggest a cave. For those not familiar with Randy; he retired from the MTNF about 2005, but while he was working, he submitted almost 200 reports on various caves on MTNF. We have over 1300 different sources supplying reports to the database; 200 reports rank one in the top 2% of sources writing reports. Thankfully, most of the top 2-4% are active cooperators today, within the MSS. Richard Orr sent: -Via Facebook and "private" Messenger, entrance pictures of Hittle and Roaring Springs Caves in Franklin Co. He also found a new cave, Beaver Lodge Cave now, nearby. Jim Ruedin sent: -A monitoring form for his bio-trip to Grandpa's Hole where they recorded 8 fauna records. All now are in the database. Marissa Schorr sent: -2 Monitoring Forms with 15 or so Faunal Records and Reports on Mill Creek and Paddy Caves in Texas Co. Mick Sutton sent: -43 Faunal Records with a large component from Round Spring Caverns in Shannon Co. and quite a few historic records from the 1980s. He also filed 15 Biologic Assessments (part of the database) for caves on the Mark Twain NF in Barry Co. -Another round of over 40 Biologic Assessments for cave on the MTNF in Barry Co., wrapping up the county.

-A group of 33 reports for almost as many caves in Camden, Carter, Madison, Oregon, Pulaski, Reynolds, Shannon, Texas and Washington Counties. -Some corrections for Bruin Acres Cave (?) in Pulaski Co. Fauna records are attached to this cave, but the records seemed incomplete relative to their 1948 reporting. Now we only need to find "this" cave that has epigean fish and crawfish in the vicinity. **Richard Thompson sent:** -Half a dozen photos of Lon Odell Memorial Cave in Dade Co. **Rosie Weaver sent:** -From the Dwight Weaver's collection, a group of 23 newsletters that were not yet archived, these include: 7 copies of LOG's newsletters including 2 rare Ozark Cavers (LOG's first newsletter) and the Ozark Speleograph; 3 copies of RCCavers (hadn't heard of this high school grotto before); 4 copies from South Side Grotto (another high school club); 6 copies from St Louis University Grotto; a copy from the SSA Speleologist; an Arkansas Caver; a CRF Newsletter and lastly an MSM Spelunker. These are all great additions to the "Source" Archives. **Shannon Zaloz sent:** -Reports on 7 trips that she had been on over the last year and included 11 Faunal Records focused on 2 of the caves. She also sent over 30 photos for the caves. **Jim Zollweg sent:** -Historic sketch maps of Big Bird, Den and Reeves Shelter Caves in Crawford Co. These are maps that predate the cancellation of the Meramec dam on that river; not quite 50 years to see the light of day.—Ken Grush

Kansas City Area Grotto (KCAG). Oct. 16<sup>th</sup> - Nathan Taylor led a group of 12 from the First Baptist Church of Lee's Summit into Cleveland Cave. The group consisted of five adults and seven students from second through ninth grades. They had a very good trip, spending approximately one hour and 45 minutes in the cave. One student did turn back at the bat room, having decided that caving was not his thing. Two adults returned with him to the gate, one of which returned to catch up the group. The remaining crew of ten made it to the ladder at the balcony, where another adult decided that was enough for him. He remained at the ladder while

the rest continued to the bitter end. A couple kids explored to the adult-passable limit of Bitter End Crawl, and would have gone further if Taylor had not reigned them in. Not all project cave work occurs underground! Oct. 18th - Don Toole of Climax Springs, Missouri was joined by Gary and Alberta Zumwalt, Jim Lehr, and Jim Cooley to install a ten-foot-wide metal cattle gate in a barbed wire fence at the far end of a very long cow pastures. Fence posts and gate were supplied by the landowner. This cattle gate was required to support the building, a fly-over-style, bat friendly cave gate to protect a huge, Priority 1 gray bat maternity colony near Climax Springs, in Camden Co. The bat cave, alas, was inconveniently located on the OTHER side of that barbed wire fence. First order of business was to carefully drop a huge widow-maker (teetering tree) that mightily resisted dropping, before it mightily fell. Posts were then set and the cattle gate was then installed without further incident, in about four hours. The ACTUAL, insidethe-cave CAVE gate, a mere 45 feet wide by 20 feet tall at the apex, requiring eight tons of steel funded by USFWS, will be built March 31st-April 10th, 2022. We're looking for several volunteers to help.

Oct. 13<sup>th</sup> - 17<sup>th</sup> - Some MVG members went to the TAG fall cave in and did several vertical caves.—Alex Litsch

Sept. 4th - JJ Huelsing & Allan Breite continued cleanup of a St Charles Co. sinkhole. Sept. 12th - JJ Huelsing & Allan Breite ridge walked in St Charles Co. locating several new cave leads. Sept. 19th - Allan Breite & JJ Huelsing attended MSS meeting at Bennett Springs SP. Sept. 26<sup>th</sup> - Allan Breite, JJ Huelsing and TJ Griffin continued cleanup of a St Charles Co. sinkhole. Sixteen vertical feet of debris has been removed to date amounting to about 40 cubic yards of trash and debris since December 2020. Oct. 16th - Allan Breite, JJ Huelsing, Rich Orr, Dawn Martin, Kevin Berdak & TJ Griffin did a trip into Illinois Caverns. Trip and Faunal reports with photos were submitted to the MSS Cave Files. The group also visited the Paul Whiteman Subterranean Preserve as an additional short above ground side trip while in the area afterwards. Oct. 22<sup>nd</sup> - 24<sup>th</sup> - Rich Orr attended the Fall MVOR gathering in Noel, MO on behalf of Stygian Grotto. 
Springfield Plateau Grotto (SPG). Sept. 11<sup>th</sup> – 12<sup>th</sup>—Jon Beard participated in a Roubidoux Cave (Pulaski Co) graffiti and trash removal trip. Jon furnished much of SPG's restoration equipment and supplies including PPE (safety glasses and N95 dust masks). Although Jon removed a couple of graffiti words and part of another, he concentrated on profuse spray paint graffiti in six colors on the entrance passage's best flowstone display. More work is needed there, but every bit helps. The cave has been recently leased by the MCKC which continues to add to its arsenal of managed, leased and owned caves. Sept. 25<sup>th</sup>—Chris Lewis and Jon Beard led a large group from Missouri State Univ. through Fitzpatrick Cave (Christian Co.) and nearby Breakdown Cave, showing them various features. One of the group, a geology professor, took 3-D images in Fitzpatrick as part of a project to produce a virtual cave trip for classes. Oct. 18<sup>th</sup>—Alicia and Jon Beard photographed Ha Ha Tonka Natural Bridge (Camden Co.) on a hiking trip to the state park on a pleasant afternoon. The park features some of the most spectacular karst features in the state—deep, wide collapse sinks, a large spring, etc. Oct. 23<sup>rd</sup>—Jon Beard was joined by Chase Cunningham in the removal of the last of the graffiti in the lower (main) level of Fitzpatrick Cave (Christian Co.). The only signatures remaining were written in 1880 and 1900 and are considered historically significant and are unobtrusive. After this Jon gave Chase a tour of Paul's Gallery where speleothem reattachments are being made. They also visited the main room of nearby

Breakdown Cave. **Oct. 24th**--- Nathan Burton checked the Entrance Passage of Old Spanish Cave (Stone Co.) and found 3 Pickerel Frogs, 2 Big Brown bats, 14 salamanders and thousands of mosquitoes. - Material furnished by Jonathan Beard and Nathan Burton. Report by Max White.

Lake Ozarks Grotto (LOG). needed volunteers to install a gate in a barbed wire fence for access to the cave. LOG member, Don Toole, volunteered since he lives in the area. MSS MINUTES. The Fall 2021 Board meeting of the Missouri Speleological Survey was called to order by President Dan Lamping on September 19<sup>th</sup>, at Shelter A in Bennett Spring State Park. Officers present: Dan Lamping, President; Krista Bartel, Vice-President; Don Dunham, Treasurer; and Alberta Zumwalt, Secretary. Directors present: Rita Worden, Chouteau; Jim Cooley, KCAG; Gary Zumwalt, LOG; Joe Sikorski (proxy for Alex Litsch), MVG; Max White, SPG; Don Dunham (proxy for Doug Leer), MMV; Krista Bartel (proxy for Bob Lerch), CCC; Jeff Fennell, Daedalus; Alex Litsch (proxy for Alicia Wallace), MCKC. Allan Breite, Stygian, was seated during meeting. Absent were: Cairn, LEG, MSM (affiliation fee not paid), PEG, RBX (fee not paid), OHG (no representative) and SEMO. Secretary's report. The minutes of the Spring 2021 meeting were emailed to the Officers and Directors, and printed in the May-June MSS Liaison. MSS Liaison. Gary Zumwalt reported cash on hand of \$148.33; Sending out 33 paper copies and the rest as electronic copies, the next deadline is Nov. 1st. Treasurer's Report. Don Dunham reported: REPORT OF THE TREASURER - August 31, 2021 - ACCOUNTS: General fund \$10085.74; Subscriptions/Donations Missouri Speleology \$9286.44; Research Fund \$9284.78; Anne Johnson Data Fund \$17914.77. Affiliation fees \$1377.00; Subscriptions Liaison \$261.00; Total \$48209.73. ASSETS: Savings bonds \$2000.00; Interest checking \$10209.73; Certificates of deposit \$36000.00; Total \$48209.73. Don reported that the \$2,000 savings bonds, set up in 1994, will come due in 2 years and will be worth \$6,000. He said the money is ear-marked for research. Missouri Speleology. Don Dunham said that Vol. 64 has been published – Marvel Cave issue. He said that the author, Bob Thompson, did most of the work on it. The next issue may be a manuscript by Tom Aley. Old Business. Frequency of MSS meeting. Pres. Lamping went over the proposed meeting changes to the bylaws. The current bylaws say: A. There shall be a minimum of three meetings per year, in the Fall, Winter, and Spring at specific dates specified by Board action. B. Special meetings may be called by the President with at least 30 days advance notice to all Board members. The proposed bylaws change is as follows: A. There shall be a minimum of two meetings per year. B. Meeting dates, locations and/or formats (in-person or online) shall be determined by the President and approved by the Board either in person or via electronic communication with at least 30 days advance notice to all Board members. In the event of electronic communication (email), approval of upcoming meeting dates, locations and/or formats shall be determined by a vote of the majority of Board members who respond to the call for a meeting within two weeks. C. Special meetings may be called by the President with at least 30 days advance notice to all Board members. Gary Zumwalt made a motion to accept the bylaw changes, seconded by Rita Worden. Max White said he had talked on the phone with him and that he wants to make sure it is in legal documents. Alex Litsch said that the MCKC had discussed the matter and there was an interest in the property. Jim Cooley talked about strategy and offered ideas. Rita Worden made a motion to respectfully decline the land donation and support the land to be offered to the MCKC. Seconded by Gary Zumwalt. Passed. New Business. Treasurer – Pres. Lamping re-appointed Don Dunham Treasurer for three more years. Research Council – Pres. Lamping re-appointed Jeff Crews and Doug Gouzie for three more years. Other members are Mick Sutton and Bob Lerch. Affiliate Organization. Pres. Lamping said that Stygian Grotto has fulfilled all the requirements to be an affiliate organization. Jeff Fennell made a motion to accept Stygian Grotto as an affiliate organization of the MSS. Seconded by Alex Litsch. Passed. Allan Breite seated on the Board as Stygian Director. Pres. Lamping explained that the \$25 affiliate fee goes to the general fund and helps to fund the organization getting MoSpeleo. Roubidoux has not been attending meetings and have not paid the fee which was due in January so they can lose representation on the Board. Cave Files Committee. Pres. Lamping said that MODot has a copy of the database to enable them to plan highways away from caves. He said the Cave Files Committee is giving the Corps of Engineers a stripped-down data base with locations only. Agency Reports. Pres. Lamping said that there will be a change in obtaining permits for MDC caves. They are hoping it will be revised and streamlined. They are working with Shelly Colatskie. Affiliate Organizations project reports. MCKC. Alex Litsch reported that the MCKC has acquired Roubidoux Cave in Waynesville. He said they have a camera onsite and have already caught trespassers. Their priority will be to control visitation. There is a sign posted on the site with contact information. If they are unable to control the access, then they will consider gating. CCC. Jim Cooley said there is a discussion going on to possibly dissolve the CCC into the MCKC. Announcement. Gating project. Jim Cooley has a gating project scheduled for Mar 30<sup>th</sup> – Apr. 10<sup>th</sup> of a large cave in Camden Co. The entrance is 35' wide and 25' tall. The gate will be funded by Fish & Wildlife. It is home to a lot of bats and histoplasmosis. Camping will be on site and food will be provided. Krista Bartel asked if welders are needed. Jim said that Joe Williams and Alicia Wallace will be welding but could use some welders during the week. MSS Treasury. Don Dunham said he just found out that all interest from accounts goes into the general fund. He also said he has t-shirts and stickers available. Mary Lawson Cave. Pres. Lamping said that 4400 ft. is surveyed. He said there are thousands and thousands of bats, probably more than the MDC knows. They only allow two weekends per year to go into the cave. Next MSS meeting. Pres. Lamping said that it has been suggested to have the next meeting March 2022 in Perryville, in conjunction with a public outreach event organized with the City of Perryville. The meeting would have to be either the first weekend or the 2<sup>nd</sup> weekend. Allan Breite said the 2<sup>nd</sup> weekend would work better for them. A motion was made and seconded to have the meeting the 2<sup>nd</sup> weekend of March. Passed. Question raised if meeting would be on Sunday - possible conflict if on Saturday. Pres. Lamping said he would have to check when we could have the meeting and it would be announced at a later date. Meeting adjourned. - Respectfully submitted, Alberta Zumwalt, Secretary.



#### SAVE THE DATE: Springtime in the Ozarks! Cave gating in Climax Springs, MO next April...



Hello Fellow Cave Conservers,
Critter Lovers, and Wild-Eyed
Conspiracy Conservationists of all
stripes and species: We have finally set
the dates for the construction of a batoptimized cave gate at Climax Springs,
MO. The project will start the morning
of Friday, April 1<sup>st</sup>, 2022 and conclude
no later than Sunday, April 10<sup>th</sup>, 2022 –
and hopefully well before! Cave
Research Foundation will be building a
large, fly-over style cave gate to protect
a HUGE maternity colony. This
cave houses on average around

115,000 maternal gray bats every summer. Gray bats are a Federal and state listed endangered species; their maternity colonies are especially susceptible to disruption. This site has seen repeated trespassing, but no big juvenile gray bat kills – *yet.* Our goal is to keep it that way. This project is funded by the U.S. Fish and Wildlife Service, the agency responsible for administering the Endangered Species Act. We are looking for ablebodied volunteers to help build this gate, especially during the April 1<sup>st</sup>-April 6<sup>th</sup> time frame. This is a BIG project and we'll need a LOT of help. There is plenty of good camping on site, and we'll have grub every day and a campfire every night. This will be a fun project. Please drop me a quick note letting me know which days you can participate. I am now working to get the crew lined up for this excellent adventure. – Jim Cooley
